The following items must accompany the application form

1. An application fee per licence. To obtain the current application fee, please contact VicRoads.
2. If the transferee (purchaser) is a company, a current (not more than 3 months old) Australian Securities and Investments Commission (ASIC) **company extract listing all directors must be provided.**
3. If the transferee (which includes all directors if it's a Company) is not the holder of a current Accident Towing Driver Authority, a current (not more than 6 months old) National Police Certificate must be provided. To obtain a certificate forward a completed "Consent to Check and Release National Police Record" form **direct to Victoria Police.** Wait for the "National Police Record Certificate" to be returned to you before submitting the application for the transfer of tow truck licence/s.
4. Proof of ownership of the premises from where the tow truck is proposed to be operated from.
Either of the following will be accepted:
 - A copy of a rate notice in the name of the transferee; or
 - A copy of a leasing agreement between the transferee and the owner of the premises; or
 - A copy of a sub-leasing agreement between the transferee and the lessee, together with written consent from the owner of the premises.

Change of Depot Address

If the transfer of tow truck licence/s also includes a change of depot address, an "Application for Variation of Conditions of Tow Truck Licence/s" completed by the current licence holder/s, will be required to accompany this application.
