## Deceased Estate

VicRoads recognises that the death of a relative or friend is a difficult time. This pack has been prepared to help you resolve driver and marine licensing and vehicle and vessel registration matters as simply as possible.

We will endeavour to deal with your needs in a sensitive manner which respects your privacy. We trust that you will understand that certain requirements must be met to protect the Estate and ensure the legitimacy of transactions.

### What needs to happen when a person is deceased?

Step 1 – Notify VicRoads that the person is deceased

Step 2 – Establish the authorised representative of the Estate

## Step 1 – Notify VicRoads that the person is deceased

While VicRoads is notified periodically of deaths recorded by Births, Deaths and Marriages Victoria, it is in the interests of the Estate to notify VicRoads as soon as possible that the person is deceased. This can be done:

- in writing (include a certified copy of the death certificate) to VicRoads, GPO Box 1644, Melbourne, Victoria, 3001; or
- in person (bring the original or a certified copy of the death certificate) at a VicRoads Customer Service Centre.

An original or certified copy of the death certificate must be sighted by VicRoads.

If a person has died overseas, an overseas death certificate will be accepted, providing it is in English or accompanied by an English translation from an interpreter who is accredited or recognised by the National Accreditation Authority for Translators and Interpreters (NAATI).

*Original documents must not be mailed to VicRoads as they will not be able to be returned. A death certificate presented in person at a VicRoads Customer Service Centre will not be copied or retained and will be returned to you.*

## Step 2 – Establish the authorised representative of the Estate

This may be done when you first notify VicRoads of the death, but if this is not possible, it must be done as soon as possible, after that date. It is important to note that VicRoads will not be able to process any transactions until Step 1 and Step 2 have been completed.

There are two parts to this step and they must be completed by the authorised representative of the Estate attending a VicRoads Customer Service Centre:

### 2.1) Establish the identity of the person who is to represent the Estate

The representative of the Estate must provide their current (or expired by no more than two years) photo Australian driver licence/learner permit or satisfy VicRoads normal evidence of identity requirements – please visit [vicroads.vic.gov.au](http://vicroads.vic.gov.au)

### 2.2) Establish that the person has authority to represent the Estate

This will require VicRoads to sight an original or certified copy of:

- i. the relevant section of the Will; or
- ii. a Grant of Probate issued by a Supreme Court of an Australian State or Territory; or
- iii. Letters of Administration; or
- iv. where none of the above exist and the estate is worth less than \$10,000, a Statutory Declaration for the Administration of a Deceased Estate form from a person, typically a spouse or domestic partner, parent, child or sibling (who is at least 18 years of age) stating that there is no Will or grant of representation and declaring that she or he is entitled to represent the estate.

VicRoads will not copy or retain the Will, Grant of Probate or Letters of Administration. Documents created for the purpose of submission to VicRoads such as a statutory declaration will be retained for VicRoads record.

If there is more than one executor or administrator, a letter, signed by all executors or administrators must be provided nominating which person will represent the Estate. The nominated person may expressly authorise in writing a third party (agent) to undertake transactions on behalf of the Estate.

Please refer to [vicroads.vic.gov.au](http://vicroads.vic.gov.au) for advice on evidence of identity and authority to act requirements for agents.

## Step 3 – Decide what you need to do

Step 3 is for the authorised representative of the Estate to identify the transactions that need to be undertaken. This Step can be undertaken at the same time as Step 2.

If a transaction is to be undertaken at another time, the authorised representative will need to provide evidence of identity at a VicRoads Customer Service Centre as per Step 2.1.

## Cancel a driver licence, learner permit or marine licence

A driver licence, learner permit or marine licence may be cancelled by the authorised representative of the Estate. This can be done by completing the *Cancellation and refund request form*.

VicRoads will deduct an administration fee from the refund amount. Where the refund amount is less than the administration fee, no refund will be issued, and the authorised representative will be advised of this in writing. All refunds will be made payable by cheque to the Estate and posted to the authorised representative.

No refund is payable for a learner permit.

*At the time of cancellation, if a request is made for a licence or permit to be returned to the Estate after cancellation, it will be invalidated.*

## Transfer a vehicle or vessel registration

When VicRoads has been notified that a person is deceased, it will write to the deceased person's Estate (if necessary), requesting that the registration of any vehicles or vessels be cancelled or transferred to the name of the authorised representative of the Estate on a temporary basis, pending settlement of the Estate, or another person where the entitlement has been resolved.

VicRoads records the registered operator of a vehicle or vessel. This is not necessarily the owner. Transfer of registration does not transfer ownership of a vehicle or a vessel.

The requirements to transfer the registration of a vehicle to a new operator are set out in the table below. The requirements vary as certain exemptions are provided in legislation.

Vehicles registered in the name of a company or other incorporated body are subject to normal transfer requirements.

No exemptions apply to vessel transfers. Normal transfer requirements apply, complete the *Application for transfer of vessel registration from deceased estate form*.

If there are multiple vehicles or vessels, you need to complete one form for each registration to be transferred.

If there is a court order specifying to whom the vehicle or vessel is to be transferred, an original or certified copy must be sighted by VicRoads in addition to the transfer requirements.

## Vehicle registration requirements

### Cancel a vehicle or vessel registration

If a vehicle or vessel is still in the name of the deceased person, or is in the name of the Estate or its authorised representative, the authorised representative of the Estate may request that the registration be cancelled.

Vehicle requirements:

- Return the number plates to VicRoads and complete a *Cancellation and refund request* form; or
- If the number plates have been lost, damaged or destroyed, complete a *Cancellation and refund request* form, including the section about non-return of number plates; or
- If custom plates are to be retained, advise VicRoads that the number plates will be held in 'self-retention' (please refer to the Transfer/retain custom number plates section) and complete a *Cancellation and refund request* form to claim a refund of the unexpired portion of the registration and Transport Accident Commission charges.

Administration fees will be deducted from the refund amount. Where the refund amount is less than the administration fee, no refund will be issued, and the authorised representative will be advised of this in writing. All refunds will be made payable to the Estate.

Vessel requirement:

- Complete a *Cancellation and refund request* form, providing the vessel registration number and if possible, hull identification number.

Please note there is no provision for refund of vessel registration fees under the *Marine Safety Act 2010* or Marine Safety Regulations 2012.

### Register an unregistered vehicle or vessel

If a vehicle or vessel has become unregistered, normal re-registration requirements apply (please refer to [vicroads.vic.gov.au](http://vicroads.vic.gov.au) for details).

Vehicles being registered temporarily in the name of the authorised representative pending settlement of the Estate are exempt from motor vehicle duty.

Vehicles being registered in the name of a spouse or domestic partner are also exempt from motor vehicle duty.

For more information please refer to Table 2.

### Transfer/retain custom number plates

The display rights to custom number plates, assigned to a vehicle, are transferred with the transfer of the vehicle's registration.

If the display rights to custom number plates are not to be transferred with a registration, the plates must be removed before the registration is transferred. New number plates will be required to be assigned to the vehicle unless its registration is to be cancelled.

Custom number plates which are to be retained by the Estate which are not to be assigned to a vehicle should be held in 'self-retention'.

To request that custom number plates be recorded as being in 'self-retention' the authorised representative of the Estate will need to:

- complete all sections of a *Transfer of registration number rights agreement for deceased estate* on behalf of the Estate
- keep the plates safely in his/her possession
- not fit the plates to any other registered vehicle prior to VicRoads assigning the number to the vehicle at the request of the registered operator.

It is important that custom number plates which are not assigned to a registered vehicle are placed in 'self-retention' as the rights to display the plates may otherwise lapse.

When custom number plates are not assigned to a vehicle but the rights to display the plates were held by the deceased, and are now to be transferred, the authorised representative of the Estate and the buyer must complete a *Transfer of registration number rights agreement for deceased estate*.

# Application for transfer of registration from deceased estate

## What is a transfer of registration?

A transfer of registration is a change of the registered operator<sup>1</sup> of a registered vehicle. VicRoads records the identification details of each vehicle and the current registered operator of the vehicle.

**VicRoads' vehicle register is not a register of title (vehicle ownership).**

### Disposer instructions

You need to provide complete and accurate information so the registration can be transferred successfully. **Otherwise, you may be liable for any traffic offences that the acquirer (new registered operator) may incur.**

#### What do I need to do?

- Tell the acquirer if the vehicle is recorded on the Victorian or an interstate written-off vehicles register. You must disclose this to the acquirer in writing (by answering Yes or No to this question in the **Vehicle details** section and provide any other details to the acquirer).
- Ensure the vehicle registration is still current (not suspended or cancelled), check online at [vicroads.vic.gov.au](http://vicroads.vic.gov.au).
- Check that there are no outstanding fines, warrants or sanctions issued by the Sheriff which may prevent this transfer – more information at [fines.vic.gov.au](http://fines.vic.gov.au).
- Do I need to get a Certificate of Roadworthiness (RWC)?**  
The Deceased Estate Pack sets out the requirements that most commonly relate to deceased estates.  
For information on caravans, light trailers under 4.5 GVM, recreational motorcycles and vehicles not designed primarily for carrying passengers or goods, please check VicRoads' website [vicroads.vic.gov.au](http://vicroads.vic.gov.au).
- Write a receipt for the acquirer as proof of purchase and ownership, and include the registration number, VIN or chassis number and acquirer and disposer name. (This transfer form cannot be used as a register of title.)
- Complete the **Disposer<sup>3</sup> details** and **Vehicle details** sections and sign this form with the acquirer.
- Give the **original** transfer form to the acquirer to submit to VicRoads.
- Keep one of the copies as a record of the application for transfer and date of transfer.

#### How do I transfer with custom or personalised plates?

If you dispose of the vehicle **with** custom or personalised number plates attached and current registration<sup>2</sup>, rights relating to the use of the number plates will pass to the acquirer.

If the rights to the custom or personalised number plates are to be kept for future use, you need to tell VicRoads and get new number plates for the vehicle before you transfer the registration.

## Do I need to use this form?

- Yes:** To acquire or dispose of a vehicle with number plates attached and current registration<sup>2</sup>.
- No:** To acquire or dispose of a vehicle without number plates and/or with cancelled registration, do not use this form. For further information please visit [vicroads.vic.gov.au](http://vicroads.vic.gov.au)

### Acquirer instructions

You need to provide complete and accurate information so the registration can be transferred successfully. **Otherwise, the registration will not be transferred and may be suspended.**

You should receive confirmation by mail within 14 days if your transfer is processed successfully.

#### How do I check the vehicle details?

- Confirm the disposer is the authorised representative of the estate.
- Confirm registration status is current (not suspended or cancelled).
  - Check these details online at [vicroads.vic.gov.au](http://vicroads.vic.gov.au) with the registration number or Vehicle Identification Number (VIN)<sup>10</sup>.
- Confirm that the vehicle is not reported stolen, not recorded written-off and is free of encumbrance, outstanding fines, warrants or sanctions issued by the Director, Fines Victoria (eg. money owing).
  - Check these details by contacting the Personal Property Securities Register (PPSR) online at [ppsr.gov.au](http://ppsr.gov.au) or call 1300 007 777 (1300 00PPSR).
- If the registration is close to expiry, a renewal notice may have already been issued to the disposer. After the transfer is processed successfully, a new one should be sent to you by mail.

#### How do I complete the transfer?

- Ask the disposer if the vehicle is recorded on the Victorian or an interstate written-off vehicles register. If it is, they must disclose this to you in writing (see **Vehicle details** section on form).
- Ensure number plates are attached to the vehicle. If you acquire a vehicle **with** custom or personalised number plates attached and current registration<sup>2</sup>, rights relating to the use of the number plates will pass to you.
- Check the VIN<sup>10</sup> or chassis number matches the registration certificate or check these details online at [vicroads.vic.gov.au](http://vicroads.vic.gov.au)
- Ask the disposer for a Certificate of Roadworthiness (RWC)<sup>11</sup>. The registration number on the RWC must match the number plates on the vehicle.
- Ask the disposer for a written receipt as proof of acquisition and ownership for your records.
- Record the market value<sup>12</sup> (where applicable) and calculate the motor vehicle duty (see how to calculate overleaf). Penalties may apply if a person under declares the market value.
- If you do not possess a Victorian driver licence/learner permit or are not an established VicRoads client, you must present original evidence of identity documents along with this application at a VicRoads Customer Service Centre.
- Complete the **Acquirer<sup>4</sup> details**, **Transfer details** and **Payment** sections, check the **Vehicle details** section and sign this form with the disposer.
- Give one copy to the disposer and keep the other for your own records.
- Submit the original transfer form with relevant documents and applicable payment (see overleaf) to VicRoads within 14 days of acquisition.** You may need to pay a penalty or additional fees if this is late or not submitted.

## Definitions

- Registered operator** – an individual or corporation who owns or manages a vehicle and has the right to register it. To register a vehicle the individual must be at least 17 years for a light vehicle, 17 years and 9 months for a motorcycle, and 18 years for a heavy vehicle. There can only be *one* registered operator per vehicle (no joint registration).
- Current registration** – registration expires at midnight of the registration expiry date. VicRoads will cancel the registration if it is not renewed within three months after expiry. The registration can still be transferred during this three month period, but the vehicle must not be driven until registration is renewed. If the vehicle does not meet this definition, do not use this form and check VicRoads' website on buying and selling (not a transfer).  
For heavy vehicles registered under part-year registration see VicRoads' website.
- Disposer** – the individual (current registered operator) who is disposing of the vehicle.
- Acquirer** – the individual or corporation who is acquiring the vehicle (proposed registered operator).
- Surname and given name(s)** – must match the name on an individual's Victorian licence or evidence of identity documents.
- Company name** – the name of a corporation registered with the Australian Securities and Investments Commission (ASIC). *For example, 'Sample Cars Pty Ltd'.*  
Trading names cannot be used to register a vehicle.
- Australian Company Number (ACN)** – a unique nine digit number issued to a company by Australian Securities and Investments Commission (ASIC).  
Australian Business Numbers (ABNs) cannot be used to register a vehicle.
- Victorian driver licence / client number** – provide a Victorian driver licence/learner permit number for a licence/learner permit holder or a client number for a corporation. A client number is a unique nine digit number issued by VicRoads to corporations and individuals without a Victorian driver licence or learner permit. If you are an established VicRoads client, but do not know your client number, please ensure all other details are completed.

Individuals who do not have a Victorian driver licence/learner permit number, and individuals or corporations who are not an established VicRoads client, will need to present full evidence of identity documentation with this application at a VicRoads Customer Service Centre.

- Garage address** – where the vehicle will normally be kept (eg. home, office or heavy vehicle depot). VicRoads will only register vehicles garaged in Victoria. If the garage address is (or will be) in another state you must register the vehicle there. If you change any of your details you must notify VicRoads within 14 days.
- Vehicle Identification Number (VIN)** – a unique 17 digit identifier made up of numbers and letters on a vehicle. If there is no VIN (eg. on pre 1989 vehicles), provide a chassis number.
- Certificate of Roadworthiness (RWC)** – also known as a Roadworthy Certificate, issued by a Victorian Licensed Vehicle Tester to certify if a vehicle is in roadworthy condition. It is valid for 30 days from the date of issue, unless a defect notice is issued within the period of validity.  
Please refer to the disposer instructions in the deceased estate pack.
- Market value** – also known as dutiable value, is the price at which the vehicle might reasonably be sold, free from encumbrances, on the open market; or the purchase price – whichever is greater.  
*For example, if the acquirer paid \$4000 but the vehicle would normally be worth \$5000, the market value is \$5000.*  
*For example, if you pay greater than the normal market value due to a vehicle's condition, the dutiable value is the amount paid.*
- Date of transfer** – refers to the date of transfer or delivery, when the acquirer acquires the vehicle from the disposer.

## Penalties

The disposer must inform the acquirer in writing if the vehicle is recorded on the Victorian or an interstate written-off vehicles register. Failure to do so may result in a penalty of over \$1000. The acquirer must complete and sign this application with the disposer and submit to VicRoads with relevant documents and pay the applicable motor vehicle duty and transfer fee within 14 days of acquisition. Failure to do so may result in a penalty of over \$500 (Road Safety (Vehicles) Regulations 2009).

This application for transfer of registration of a motor vehicle is an assessment of duty (section 217A). A person who under declares the market value is liable to a penalty equal to double the amount of duty underpaid (section 215). A person who underpays motor vehicle duty is also liable to a penalty equal to the amount underpaid plus interest (section 217). (*Duties Act 2000*).

A person who underpays the motor vehicle duty may also be liable to a penalty tax and interest. (*Taxation Administration Act 1997*).

## Acquirer instructions continued

### Do I need to provide evidence of identity?

**Individuals:** Yes, if you do not have a Victorian driver licence/learner permit or VicRoads client number, you must present full original evidence of identity documentation with this application at a VicRoads Customer Service Centre.

**Companies:** Yes, if you do not have a client number with VicRoads, you will need to present evidence of your company with this application at a VicRoads Customer Service Centre.

Please check [vicroads.vic.gov.au](http://vicroads.vic.gov.au) for requirements.

### How do I lodge this application?

You must submit this form with relevant documents (eg. RWC) and applicable payment within 14 days of acquisition by:

- mail (cheque or money order) to:

Payment can also be made at a VicRoads Customer Service Centre using Mastercard or Visa. A card payment fee will apply in addition to any amounts payable. Details of the fee are available at [vicroads.vic.gov.au](http://vicroads.vic.gov.au). **A confirmation advice will be sent to you within 14 days of a successful transfer of the vehicle registration.**

**Important:** If you need to provide evidence of identity, present your original documents along with this application in person at a VicRoads Customer Service Centre. If you are required to provide evidence of identity, your application for a transfer of registration will be processed at the VicRoads Customer Service Centre that you attend. Check [vicroads.vic.gov.au](http://vicroads.vic.gov.au) or call (03) 8677 7855.

### How do I apply on behalf of someone else or a company?

You must provide evidence of identity and an original signed letter of authority to act on behalf of another person or a company at a VicRoads Customer Service Centre. The letter must nominate the vehicle to be transferred.

## Do I need to pay fees?

**The requirements to transfer the registration of a vehicle from a deceased person to a new operator are set out in the table in the Deceased Estate Pack. It should be noted that the requirements vary as certain exemptions are provided in legislation.**

### Transfer fees

Motor vehicle - \$39.70

Motorcycle/Trailer/Caravan - \$6.40

Fees are subject to change. A card payment fee will apply for Mastercard or Visa payments. For further information visit [vicroads.vic.gov.au](http://vicroads.vic.gov.au)

### Motor vehicle duty

Where motor vehicle duty is payable, the correct market value must be recorded. The correct market value is the price at which the vehicle might reasonably be sold, free from encumbrances, on the open market, or the purchase price – whichever is the greater.

The amount of motor vehicle duty payable is \$8.40 for every \$200 or part thereof of the market value.

### Motor vehicle duty common exemptions

The Deceased Estate Pack provides information on motor vehicle duty exemptions that most commonly relate to deceased estates. For other exemptions and related evidence requirements please check VicRoads' website.

You can calculate motor vehicle duty online at [vicroads.vic.gov.au](http://vicroads.vic.gov.au)

### How to calculate motor vehicle duty

“plate style” means the design, size, colour or material used by VicRoads for a series of custom plates;

“plates” includes a single plate, unless the context otherwise requires;

“registration number rights” means the rights set out in section 5AD of the Act;

“your plates” means custom number plates issued by VicRoads displaying your registration number; and

## Assigning the registration number and attaching plates

2. Once you have received your plates, you may have the registration number assigned to a registered vehicle. You may do this by calling VicRoads or visiting a VicRoads Customer Service Centre. There is no charge for the first assignment of the registration number to a registered vehicle. There is no need to contact VicRoads if the new plates are for a bike rack or an exempt trailer, or if they display the same registration number as the plates currently assigned to the vehicle.

3. VicRoads will only assign a registration number to a vehicle that is registered in your name. If the registration number rights are owned by an incorporated body, VicRoads will only assign the registration number to a vehicle registered in the name of that incorporated body.

4. You must not attach your plates to a vehicle until the registration number has been assigned to that vehicle. It is an offence to display plates on a vehicle if the registration number on the plates has not been assigned to the vehicle by VicRoads. Once the registration number is assigned to your vehicle, you must attach your plates. If you are intending to have a car dealer attach your plates for you, leave them in the box provided by VicRoads, and take the whole package to the dealer.

5. If you purchase replacement or upgrade plates with the same number as plates you already own, you must return any old plates showing that registration number to VicRoads. You may not dispose of the old plates in any other manner. All plates remain the property of the State.

## Self-retention of number plates

6. If plates have been issued but you do not want them to be affixed to a vehicle, the plates must be held on ‘self retention’. If your plates are affixed to a vehicle and you wish to remove them and not affix them to another vehicle, you must place them on self retention by calling VicRoads or by visiting a VicRoads Customer Service Centre. If you do not wish your number plates to be assigned to a vehicle immediately, you must ensure that they are kept safely in your possession, and are not fitted to a vehicle until you have notified VicRoads. (When you receive new plates, they are automatically treated as being on self retention until the number is assigned to a vehicle, and you do not need to notify VicRoads.)

7. While your plates are on self retention, you must keep them in a secure location and do everything you reasonably can to prevent their loss, destruction, theft or unauthorised use. You must comply with any reasonable direction of VicRoads in relation to the storage or security of your plates. You must not allow them to be attached to a vehicle unless VicRoads has assigned the registration number to that vehicle. Where VicRoads is not satisfied that plates on self retention are being kept secure, VicRoads may require you to return your plates to it within 14 days. If you do not do so, you must pay VicRoads any expense it incurs in recovering your plates. All plates remain the property of the State.

8. If your plates are on self retention you may have them assigned to a vehicle at any time. You may do this by calling VicRoads or visiting a VicRoads Customer Service Centre. There is no charge for the first assignment of your registration number to a vehicle. However, if the plates were previously attached to a vehicle, a fee is payable to have the number assigned again, whether to that vehicle or another vehicle.

## Cancellation of registration number rights and return of plates

9. Your registration number rights may be cancelled by operation of the Act, in accordance with the Regulations, where there is a breach of these terms and conditions or if VicRoads decides in its discretion it is appropriate to do so. Compensation may be payable in some circumstances. If VicRoads notifies you that your registration number rights are cancelled, or your plates were issued in error, you must return your plates to VicRoads within 14 days. In any other case, registration number rights may be sold or dealt with like any other personal property.

11. Within 14 days after the transfer of registration number rights, the purchaser and seller must satisfactorily complete a *Transfer of registration number rights agreement form* and return it to VicRoads. 14. If your plates are lost, stolen, damaged or destroyed, you must apply to VicRoads for replacement plates. A fee will apply. You remain responsible for all infringements, penalties and other consequences that may result from the use by any person of the lost or stolen plates. You agree to indemnify and release VicRoads for and from any loss or liability you or another person may incur as a result of the misuse of the plates that have been lost or stolen. If the lost or stolen plates are found after you have applied for replacement plates, you must return them to VicRoads.

15. You must not display a number plate other than a number plate that has been issued by VicRoads. You must not manufacture, or ask another person to manufacture, a plate displaying your registration number, whether or not the plate has the same plate style as your plate. It is an offence to do this and any such plates are subject to seizure, and additional penalties may apply.

16. VicRoads may, at its discretion, provide for registration numbers available in one plate style to be displayed on number plates having a different plate style. - display those number plates on any vehicle to which that number is assigned by VicRoads.

If you have purchased a vehicle belonging to the Estate of a deceased person and the custom plates are attached to that vehicle, the registration rights in respect of those plates will be transferred to you (in the absence of any evidence that the transfer of the custom plate rights was not intended). There is no need for you to take any action to transfer the registration number rights.

If you have purchased, wish to acquire or have otherwise acquired (for example, through inheritance) the registration number rights held by the Estate of a deceased person and those plates are not attached to a vehicle that has been purchased by you, you must complete this *Transfer of registration number rights agreement for deceased estate* and lodge it with VicRoads.

Registration number rights are exclusive to the owner of the rights and may be exercised at any time. Exercise of the rights, however, must be in accordance with the *Road Safety Act 1986* and the *Road Safety (Vehicles) Regulations 2009*. In particular:

- The sale and purchase of registration number rights is subject to the terms and conditions set out in this document;

- VicRoads may cancel registration number rights if it considers that the registration number may be mistaken for another number, gives a misleading impression that the vehicle is owned by a government agency, is offensive, is otherwise inappropriate for public display or was issued in error. Compensation may be available in these circumstances.
- VicRoads may also cancel registration number rights if it believes the rights were acquired unlawfully or dishonestly, if the display of the number is prohibited by law or certain other obligations have not been complied with. Compensation is not available in these circumstances.
- If a currently registered vehicle to which custom plates are attached is sold, it will be presumed that the person who acquires the vehicle also acquires the registration number rights to the number on the plates.
- If the registration number rights are transferred, the vendor and purchaser must notify VicRoads of that transfer within 14 days.
- The owner of the registration number rights does not own the plates on which the registration number is displayed. All number plates remain the property of the State.
- An authorised officer of VicRoads or a member of the police force may seize a number plate if he or she reasonably suspects that it is not being used, or was not issued, in accordance with the law, and may retain the seized plate until satisfied that it can be used legally.
- VicRoads will not issue custom plates for display on vehicles that are required to be licensed or accredited (such as hire cars, taxis, buses, tow trucks or hire motorcycles). VicRoads will only issue one custom plate for display on a motorcycle.
