

General Information

This form is for use by:

- Pilot Vehicle Drivers seeking to become Certified Pilot Vehicle Drivers in Victoria;
- 'Certified Pilots' who are seeking to renew their Certified Pilot Driver Vehicle Authority; and
- Certified Pilots to notify of a change of address. (VicRoads must be notified within 14 days of a change of an address).

Pilot vehicle drivers wishing to become 'Certified Pilots' must meet the following requirements:

- Hold a current full drivers licence (not probationary);
- Have experience piloting a minimum of 20 oversize loads in the last 12 months (permit numbers, date task undertaken and operator name required);

Provide a certificate from a Registered Training Organisation (RTO) stating that you have successfully completed the following Nationally Recognised Training Competencies:

1. TLIF3060 Control Traffic as a Pilot Vehicle Operator
2. TLIC3010 Pilot or Escort Oversized and/or Overmassed Loads,
3. TLIE3009 Use Pilot and Escort Communication
4. TLIF3013 Coordinate Breakdowns and Emergencies
5. TLIB2004 Carry Out Vehicle Inspection.

Once you have completed the above you should Complete and forward this application form, with a cheque/money order made out to VicRoads or credit card details for \$56.00 per applicant and include four passport photographs and proof of pilot vehicle driver experience with a copy of your certificate certifying you have completed the training modules.

Certified Pilots wishing to renew their Certified Pilot Driver Authority must meet the following requirements:

- Hold a current licence (you are required to advise VicRoads immediately if your licence is suspended or cancelled);
- Provide four passport quality colour photographs;
- Be re-assessed for Traffic Control Certificate 'Control Traffic as a Pilot Vehicle Operator' (TLIF3060) (copy of certificate to be submitted with application); and
- Have experience piloting 40 oversize loads in the last three years (permit numbers, date task undertaken and operator name required).
- A cheque/money order made out to VicRoads or credit card details for \$56.00
- Certified Pilot Vehicle Authorities are valid for three years from the date of issue of the Traffic Control Certificate. Certified Pilots will be required to be re-assessed for traffic control every three years prior to applying for recertification.

Note: Renewal reminders are not sent. Allow 14 days for processing
